Alliance SNF Presence	Cindy Jordon from Shoreline SNF present. She reports that the SNFs are considering having liaisons go into the hospitals and was seeking clarification and guidance on how this works for the HH agencies and whether or not this is feasible. Cindy shared that SNFs face the same late discharge issues that the hospital have, including family members who show up late in the day and take patients home without prior notice. Her hope is that her attendance at these committee meetings will help bond the alliance SNFs and HH agencies through information exchange via open dialogue and collaboration.
